2025 Yukon River Salmon Fall Fishery Announcement #7 District 6 Subsistence and Personal Use Fishing Schedule

Districts Affected: Upper Yukon Area

District 6 is transitioning to fall season management. The transition will progress upriver based on fall chum salmon migration timing.

The 2025 fall chum salmon run size is anticipated to be well below average and the preseason projection is for a run size less than 200,000 fish. This is based on the relationship between summer chum and fall chum salmon run sizes. If the run comes in as projected, it will not meet the threshold of 300,000 fish needed to allow subsistence fishing, as outlined in the Fall Chum Salmon Management Plan, and will not meet the drainagewide escapement goal of 300,000–600,000 fish, tributary escapement goals, or Canadian treaty objectives. Additionally, the 2025 coho salmon run is also projected to be well below average and is unlikely to produce any surplus for harvest. Therefore, subsistence fishing for fall chum and coho salmon will be closed at the start of the fall season. Nonsalmon subsistence fishing opportunity with 4-inch or smaller gillnets and fish wheels is being reduced to protect migrating salmon and will be closed during part of the week (see schedule below).

Subsistence Management Actions:

Subdistricts 6-A and 6-B (from the mouth of the Tanana River upstream to the Wood River, including Manley, Old Minto area, and Nenana):

As previously announced, Chinook and chum salmon fishing remains closed. Subsistence fishing is open 24 hours per day, 7 days per week, with 4-inch or smaller mesh set gillnets, dip nets, beach seines, and hook and line gear for nonsalmon. Chinook and chum salmon must be released alive immediately.

Effective 12:01 a.m. on Wednesday, August 6, fall chum and coho salmon must also be released alive from selective gear types.

In Lake Minchumina and the Tolovana River drainage, including Minto Flats, subsistence fishing for nonsalmon will remain open 24 hours a day, seven days per week with 6-inch or smaller mesh gillnets.

A subsistence permit is required to fish for salmon in Subdistricts 6-A and 6-B including the Kantishna River drainage and for northern pike in the Tolovana River drainage, including Minto Flats.

Upper Tanana Area (the Tanana River from the confluence with the mouth of Volkmar River on the north bank and the mouth of the Johnson River on the south bank upstream to the Tanana River headwaters, including Delta Junction area, Dot Lake, Tanacross, Tetlin, Tok, Northway, and Nabesna):

As previously announced, Chinook and chum salmon fishing remains closed. Subsistence fishing is open 24 hours per day, 7 days per week, with 4-inch or smaller mesh set gillnets, dip nets, beach seines, and hook and line gear for nonsalmon. Chinook and chum salmon must be released alive immediately.

Effective 12:01 a.m. on Wednesday, August 6, fall chum and coho salmon must also be released alive from selective gear types.

A subsistence fishing permit is required for all species in the Upper Tanana Area.

Nonsalmon

The opportunity to harvest nonsalmon with 4-inch or smaller mesh set gillnets of 60-feet or shorter length and manned fish wheels is allowed. Fishing with these gears will be open on a weekly schedule from 12:00 p.m. noon Thursdays through 12:00 p.m. noon Sundays and will be closed for the remainder of the week. Fishermen should fish this nonsalmon gear in areas where resident species are more likely to be encountered. Fishing with other nonsalmon gears, including hand line, longline, fyke net, dip net, and beach seine, is open 24 hours a day, 7 days per week. While closures are in place for a salmon species, they must be immediately released alive from nonsalmon gear (other than 4-inch or smaller mesh gillnets).

Subdistricts 6-A and 6-B (from the mouth of the Tanana River upstream to the Wood River, including Manley, Old Minto area, and Nenana):

Effective 12:00 p.m. noon on Sunday, August 10, 4-inch or smaller mesh gillnets must be removed from the water. Fishing with 4-inch or smaller mesh gillnets and manned fish wheels for nonsalmon will reopen from 12:00 p.m. noon Thursday, August 14 to 12:00 p.m. noon Sunday, August 17, and will reopen on a weekly schedule from 12:00 p.m. noon Thursdays through 12:00 p.m. noon Sundays, until further notice.

Upper Tanana Area (the Tanana River from the confluence with the mouth of Volkmar River on the north bank and the mouth of the Johnson River on the south bank upstream to the Tanana River headwaters, including Delta Junction area, Dot Lake, Tanacross, Tetlin, Tok, Northway, and Nabesna):

Fishing is open 24 hours per day, 7 days per week, with 4-inch or smaller mesh gillnets and other selective gear types, including hand line, longline, fyke net, dip net, and beach seine. Chinook and chum salmon must be released alive immediately.

Personal Use Management Actions

Personal Use salmon fishing in Subdistrict 6-C is closed, and periods are cancelled until further notice.

Personal Use Whitefish and Sucker Fishing

Fairbanks Nonsubsistence Area (a portion of the Tanana River drainage from the Wood River upstream to the mouth of the Volkmar River on the north bank and the mouth of the Johnson River on the south bank, which includes Fairbanks, North Pole, Salcha, and Delta Junction):

Personal Use whitefish and sucker fishing with gillnets and fish wheels follows the Subdistrict 6-C Personal Use salmon fishing schedule and is closed until further notice. Fishing with other gear

for whitefish and suckers in this area remains open 7 days per week, 24 hours per day, subject to permit stipulations.

A reminder to personal use fishermen that a personal use salmon permit is required to fish for salmon in Subdistrict 6-C and a personal use whitefish and sucker permit is required to fish for these species in the Fairbanks Nonsubsistence Area. Both permits require a valid sport fishing license.

Federal Special Action

The Alaska Department of Fish and Game (ADF&G) and the U.S. Fish and Wildlife Service (USFWS) have coordinated on this advisory announcement. The USFWS Federal Inseason Manager has issued a separate Federal special action FSA 2-FC-05-25 with the same fishing schedule and restrictions for all users in waters adjacent to Federal Land.
